The country of purchase and the lot number of the product must appear on the purchase invoice.5. Certificate of analysis of the lot concerned (if available) has to be given to the Purchaser upon delivery.

**The Ordering Party will inform the Contractor about the exercise of the option right by placing an order, which will specify the number of Ultibro Breezhaler packages to be delivered and include information that the purchase of this medicine takes place under the option right. The purchase of the drug under the option law will be carried out in the same way as in the case of the basic scope and at the prices offered in the content of the offer.*

The ordering party will exercise the option right dictated by the course of the research, as part of orders that can be placed within 3 months from the date of conclusion of the contract/placement of the first order if the product series selected in the basic order is available.

The Ordering Party reserves the right not to exercise the option right. The contractor has no right to demand any remuneration for the unrealized subject matter of the contract covered by the option right. The Ordering Party reserves the right to pay only for deliveries of the drug actually ordered under the option law and received without any reservations.

Placing orders under the option is a unilateral right of the Ordering Party. Due to the Ordering Party's failure to exercise the option right, the Contractor is not entitled to any claim against the Ordering Party to exercise the option right or any claims, including those for damages.
